Current Vaccinations/Veterinarian Information: By signing this agreement, owners verify their pet(s) is current on Rabies, Distemper and Parvo-Virus vaccinations. Proof of Vaccination or current Titer testing shall be provided to Go Dog Go LLC upon request, as well as current Veterinarian information. Special circumstances will be taken into consideration.

What are the vaccination requirements?

All dogs must be current on DHPP, Bordetella, Rabies and Leptospirosis. If your dog has never had the Leptospirosis vaccine, they will need the initial shot plus the booster to be considered fully vaccinated. You must provide documentation for all vaccinations at the first session. Aggressive or Dangerous Pets: Owners MUST inform Go Dog Go LLC if their pet(s) bites, has bitten, or is aggressive to people, other pets or specific grooming procedures. If Pet is found to display aggressive action towards another pet or Go Dog Go LLC Staff Owner accepts responsibility for any Veterinary care to other pets and/or Medical care to Go Dog Go LLC Staff resulting from Pet's action. The determination of fault for such actions will be made by Go Dog Go LLC Staff witnessing the event, and their determination is final. Owner further agrees to accept responsibility for any related costs arising from incident, including the cost to repair or replace property damaged or destroyed by Pet.

Owner agrees that, should a dispute arise from any action involving Pet, Go Dog Go LLC reserves the right to release Owner's name, address, phone number, or other pertinent information to those involved, to include, but not limited to, legal entities, animal control and/or law enforcement.

Muzzles may be used if necessary. Muzzling will not harm your pet and protects both the pet and the groomer. Go Dog Go LLC reserves the right to refuse/stop services for such pet(s) at any time before or during the grooming process, and charge an Aggressive Dog Fee, in addition to the regular charge.

Use of Muzzles

Muzzling does not harm your animal and protects both the animal and the groomer. In some cases, muzzling may even calm a stressed animal, allowing the grooming process to continue. If an animal still acts in a way that is dangerous, The

Go Dog Go LLC has the right to stop grooming services at any time and a service fee will be collected. We do not muzzle unless your pet gives us a reason to. Other methods are used to calm your pet, muzzling is a last resort.

Health or Medical Problems & Senior Pets: Working your dog procedures can sometimes be stressful, especially for a senior pet or a pet with health problems. These procedures can expose hidden or aggravate known medical problems, during or after the groom. Because Senior pets with health problems have a greater chance of injury these pets will be groomed for cleanliness and comfort, in the style that will not add to their stress. In the best interest of your pet, this agreement will give Go Dog Go LLC permission to obtain immediate veterinary treatment for your pet should it be deemed necessary by Go Dog Go LLC. We will do our best to contact you first, then take your pet to your authorized Veterinarian or to the nearest available Veterinarian. It is agreed that all expenses for Veterinary care will be covered by the pet's owner upon signing this agreement.

Occasionally, working your dog can expose a hidden medical problem or aggravate a current one. This can occur during or after the session. All medical expenses for veterinary care will be covered by the animal's owner upon signing this agreement. Health or Medical Problems

Communicable Diseases

Owner understands that despite the best efforts of care and Go Dog Go LLC cleanliness, certain communicable diseases, especially, but not limited to, upper respiratory illnesses may be unavoidable in any multiple animal facility. Veterinary care, for which Owner shall be responsible, will be sought in the event Pet contracts such illness. If Pet is showing symptoms of respiratory illnesses, including canine cough, or has been diagnosed with upper respiratory disease while in the care of Go Dog Go LLC shall not be responsible for any veterinary care that your Pet receives.

Accidents: There is always the possibility an accident could occur. Even though we use extreme caution and care in all situations, possible problems could occur, including cuts, nicks and scratches. In most cases, this can happen when a pet is wiggling or moving around.

Accessories

Go Dog Go LLC is not responsible for lost or damaged Pet accessories or possessions belonging to the Owner's Pet during its boarding stay, so Owner is cautioned to leave Pet valuables at home.

This release authorizes The Go Dog Go LLC to take photos of your pet for client file and for company website and Facebook page. All photos taken are the property of The Go Dog Go LLC. Owner hereby gives absolute right and permission to Go Dog Go LLC or Go Dog Go LLC Staff, its agents, licensees, successors and assigns to use my likeness or that of my Pet for any purpose whatsoever, including, but not limited to, to publish, broadcast, and copyright my voice and video recording, name, picture, and likeness, or any material based upon or derived therefrom, or to refrain from so doing, in any manner or media whatsoever for all purposes whatsoever for any and all media and related advertising and promotion thereof. Cancellations/No call, No Show

Because we book on an 30 minute basis and cancellations can leave an empty block in the schedule that could have otherwise been used by another customer, we ask that any cancellations are made at least 24 business hours in advance.

Hold Harmless Agreement: By signing this agreement you (or your Agent) agree to hold Go Dog Go LLC, it's owners, operators, employees, officers and directors harmless from any damage, loss or claim arising from any condition of the listed pet(s), either known or unknown, to Go Dog Go LLC . It is also further understood and agreed that the terms of this agreement can change at any time, without notice, and will override any and all prior signed contracts or releases. It is further understood that this clause applies to any all pets groomed at Go Dog Go LLC. Any controversy, claim or potential cause of action arising out of, or relating to this Agreement, or a breach thereof, by any party to this Agreement shall be subject to mandatory Arbitration in accordance with the rules of the American Arbitration Association, with the with the costs of such arbitration and reasonable attorney fees absorbed by the non-prevailing party.

In releasing Pet in care of Go Dog Go LLC, Owner acknowledges that the Pet is in a good state of health and affirms that Pet will not prove dangerous or damaging to other pets, has not shown aggressive or otherwise threatening behavior to humans or other animals and is of such a temperament that it does not pose a hazard to itself, other animals, Go Dog Go LLC Staff and/or training facility.

I authorize Pet to commingle with other pets at the sole discretion of Go Dog Go LLC and Go Dog Go LLC Staff.
